I hope this mid-summer letter finds you "catching your breath" somewhat, although preparing for the start of a new school year is never a restful responsibility.



Oftentimes, the federal government is the largest land owner in the school district, yet it pays no taxes. Impact Aid is the program that helps alleviate that financial burden. Although it doesn't come close to making up for the lost tax revenue, Impact Aid is still extremely important to the school children for which you are responsible.
