- John Bernstein group continues to lobby for NAFIS •
- Period of transition in NAFIS
- Be informed, come to the FLISA summer and winter meetings, and use the financial talking points
- We have a continuing resolution through December 16th tough time to get major pieces of legislation passed with midterm elections on the horizon
- Talking Points document
- In the continuing resolution, the Senate has approved \$2 million for Section 7002. While the • increase may not ultimately be \$2 million, 7002 dollars will not be zeroed out. Request is \$79,313,000.
- When advocating, share information regarding "Advancing Toward Full Impact Aid Funding"
- Leave behind document (orange paper)
- On the NAFIS website, you can locate the "7002 payments" list that lists each district eligible for 7002 and what full funding would be for each eligible district
- Two major points: adopt what the Senate has put forth and "Advancing Toward Full Impact Aid Funding"
- Remind legislators that ESSER dollars are appreciated and impactful, but they are non-recurring and do not void the need for Impact Aid dollars
- *Punchbowl News* article Capitol is getting close to returning to normal

- Midterm elections provide a temperature check
